#### 1- Introduction by the outgoing President (M.Catalano)

Reference is made to the Report sent in September on what has been achieved in these two terms of presidency (Report attached, as part of the Minutes). In particular it was pointed out that certain elements will require continuity to improve in their concrete aspects, such as the latest "UEMS Training Requirements for Angiology / Vascular Medicine Document"in all its aspects, participation both in MJC Phlebology and the TTW (which is in the process of creation).

The need for dissemination and further committment in the Division's major activities was pointed out, in particular to stimulate Applications for UEMS European Accreditation as Training Centres (according to the rules of the document mentioned above) and the CESMA-UEMS Exam on Angiology / Vascular Medicine, now in its fifth edition.

The firmness demonstrated in recent years by the Division and the spirit of service that must characterize the role and activities of the President and the Secretary was mentioned and an appeal made for this continuity as well as the existing collaborative relationships and mutual respect with other Sections / Divisions and UEMS central Offices.

Clarification was provided on the recognition of NMA (Annex 2) and for "proxy voting", covered in the UEMS rules but considered, since its establishment, not to be accepted by the Division wishing to stimulate the active participation of its Representatives.

#### 2-Election of the new President and Secretary

-The two candidates for the presidency are: JC Wautrecht (B) and P Carpentier (F) Both have been Division members since its formation.

- Are present: 12 countries + 1 proxy (of 17 countries represented)=>76%

- Right to vote: only representatives officially appointed by NMA in their respective countries (one vote per country represented).

Have been officially appointed by the NMA : 11 Countries =65%

Are excluded from the vote: Ireland present, Represented by MP Colgan and Switzerland (Proxy to Representative of Germany)

- Debate held on whether to vote or postpone it.

The percentage of countries present required by UEMS rules is met (50% required vs 9, 65% present). The proposals to vote or postpone was put to the vote. The vote was a show of hands.

Result: 10 votes in favor of an immediate vote for the new Presidency and 1 to postpone.

### **3- Honorary Founder President proposal**

Z Peczvarady mentioned the difficult task carried out by the outgoing President to obtain the UEMS Division and the unexpected relevant results obtained in recent years.

The proposal, first put forward by K Roztočil, to elect MCatalano Honorary President of the Division, to ensure her active committment for the future.

M Catalano elected Honorary President of the Division unanimously - Vote open ballot by raised hands.

#### 4- Applications for accreditation as ETC

Proposed Centres to invite: lists to be provided by National representatives.

The Centres of the Angiology/Vascular Medicine Division representatives are expected to be among the first to send an Application (already open).

Applications - Some have already been received. The criteria have been defined and we are setting up a sound VAS-ETC Validation Committee, with representatives from different countries. Nominations for candidates are invited.

ETCs are milestone and should be an effective method to rienforce A/VM at a European level.

### 5- CESMA-UEMS EU Exam (2016, 5th Ed)

Dissemination remains a crucial point. It should be done in each country trying to find a way to stimulate interest in every single country while trying to include the CESMA-UEMS exam to the existing national reality.

Criteria will be studied to include external collaborations, in accordance with the UEMS rules. There will be no closures, if the areas are well-defined, without overlapping and that respect for decisions taken in the context UEMS by the various Organizations / Bodies are ensured.
